

NEW RATES AND TARRIFS FOR MUNCIPAL SERVICES EFFECTIVE DATE 1 JULY 2018

Notice is hereby given to the rate payers and consumers in terms of section 13 of the Local Government: Municipal Systems Act 2000 that Dipaleseng Local Municipality has by council resolution approved 20018/2019 Medium-Term Revenue and Expenditure Framework (MTREF) for levying a rate on a property and service charges. The tariffs were approved by Council on **30 MAY 2018** - Council resolution number **C102/05/18**. It is important to note that electricity tariffs are subject to the approval of NERSA.
