At the beginning of the quarter, we successfully concluded the preparatory phase in terms of our IDP & Budget Process Plan for the 2022/23 financial year.



This was followed by the timeous submission of the 2020/21 Annual Financial Statements to Auditor General as well as the 2020/21 cumulative Performance Report to Auditor General and relevant Council Structures.

The next phases over the coming months will eventually culminate the production of this current administration's very first guiding documents in terms of developmental priorities and objectives, against which as Council we will be collectively measured upon.

Also bearing in mind the rather long stretch still to be travelled with however many spiteful bends and turns along the way, it is equally pleasing to note the significant strides made thus far.

We continue to look forward to great working relations through all our structures in our service delivery quests and spirit of building and maintaining active citizenry. Public participation and stakeholder relations are crucial in these endeavours which is why we aim to create inclusive government that is not only people driven but also very responsive to community needs.

The municipality also note the instability of our electrical network in all nodal areas and Council being supported by CoGTA and DBSA, have subsequently undertaken a condition assessment of the entire electrical network infrastructure and identified critical preventative maintenance work that must be undertaken. This work is envisaged to be carried out as and when the liquidity position of the municipality allows and with the collaboration of the private sector who want to work with the municipality.

The municipality is also on the brink of forging strategic partnerships with the private sector within its area of jurisdiction. BJK and the municipality are at advanced stages of concluding a MoU in respect of technical support to man the Greylingstad Waste Water Treatment Works owing to shortages of human capital and relevant expertise to operate the plant.

Due to some of the matters noted above, the municipality suffers service delivery disruptions and/or challenges from time to time and I would like to appreciate the continued patience and understanding from our community. The institution will continue to address these in the quickest turnaround time as possible.

IDP & BUDGET PROCESS PLAN

Section 28 of the Municipal System Act (Act 32 of 2000) requires that each Municipal Council adopts a process plan that would guide the planning, drafting, adoption and review of the IDP, Budget and Performance.

The process plan should have clear and established mechanism, procedures and processes to ensure proper consultation with the local communities. It should indicate clearly how the IDP process will work, who will be responsible for what, time frames and milestones will be set and a budget will be aligned to the programme.

This quarter's implementation is depicted below and we will confidently move in a

direction that will improve service delivery efforts across all spheres, implement our set priorities to address accelerated local economic stimulation and create sustainable jobs.

Resources will be economically and effectively utilized to provide services in an impartial, fair and equitable manner. Our efforts will be to serve all people with fairness and integrity while ensuring no one is left behind.

Monday, the 3rd October 2022 saw the beginning of the municipality's weekly cleaning campaign specifically targeting illegal dumping areas throughout the municipality.

Ward 2 in Siyathemba is where the high contingent of both political and administrative leadership gathered to cleanup and to create a clean, healthy and habitable environments for the locals.

Illegal dumping site along Sebeloane street adjacent Mangweni Tarven was the first target, followed by the one at the intersection of Monareng and Mthethwa streets, lastly was the illegal dumping area near the old cemetery in Siyathemba.

All other dumping sites will follow as the week progresses.

To ensure that this initiative adequately reaches all areas of the locality, the program will rotate weekly as follows;

- 10th October – Ward 6
- 17th October – Ward 1
- 24th October – Ward 4
- 31st October – Ward 5
- 07th November – Ward 3

Post the cleaning and clearing of these sites, the community is further urged to refrain from engaging in illegal dumping.

To achieve this, where the cleaning campaign started in Ward 2, the municipality has identified a potential project of initiating a small park.

The institution together with the ward councilor is going to assemble interested young people within the ward to explore greening the public open space that was cleaned and possibly establish a car wash and/or some other related activities in order to reclaim open space and maintain clean and safe space.



PROVINCIAL WOMEN'S DAY



In her welcoming address, the Executive Mayor, Cllr. Khethiwe Moeketsi set the tone for the proceedings at the Provincial Women's Day event hosted in Dipaleseng Local Municipality by rendering acknowledgement of women who play various leading roles in today's society.

The day is celebrated against the backdrop of many challenges that women face such as inequalities in employment sector, poverty, unemployment as well as the scourge of gender based violence.

Scores of women from the breadths and depths of the Mpumalanga province gathered to witness this special day in celebration of women in the entire province.

The Premier of Mpumalanga, Relifwe Mtsweni Tsipane rendered the key note address commencing with highlighting the importance of celebrating women, particularly on this day.

She played homage to the sacrifices made by those twenty thousand odd women who marched to the union building all those years ago.

On that day, the apartheid regime sharply learned that, 'Wathint'abafazi wathint'imbokodo,' cited the Premier.

She acknowledged that women are not immune to challenges even today but further urged women to continue holding on to their values untainted by societal conforms. Women must continue to fight and pioneer for the interest of women in the midst of gender parity landscapes.

She called on our justice system to take firm stand against this by apprehending perpetrators and ensuring that they face the full might of the law.




LAND TENURE FOR MANDELA MONTH

DIPALESENG COMMEMORATES HERITAGE DAY THROUGH SERVICE DELIVERY



The 24th September was previously known as Shaka's Day for most people, in commemoration of Shaka, the Zulu king on the presumed date of his death on this date in 1828. Shaka played an important role in uniting the disparate Zulu clans into cohesive nations.

Heritage Day is a South African public holiday celebrated annually on 24 September. On this day, South Africans celebrate the day by remembering the cultural heritage of the many cultures that make up the population of South Africa. Various events are staged throughout the country such as braai to commemorate and remember this day.

The municipality chose to commemorate

this day through the delivery of much needed services to the community, and will commence with celebrations on Friday, 23rd September with handing over of a housing unit to a destitute family.

The gesture of building a low cost house is made possible through a



partnership between Dipaleseng Local Municipality and Gert Sibande TVET College. While the beneficiary identification was made jointly with the two stakeholders including local sector departments.

Further to that, another 25 housing subsidy houses will be handed over to beneficiaries from Siyathemba.

A housing subsidy is a grant by government to qualifying beneficiaries for housing purposes. One of the Department of Human Settlements' areas of responsibility in the delivery of human settlements relates to the bottom-most end of the market, where it provides housing subsidies to the poor. This is where the bulk

of the housing backlog exists, affecting mainly those who are regarded as part of the low income bracket.

The Constitution of the Republic of South Africa of 1996 enshrines the right of everyone to have access to adequate housing; and makes it incumbent upon the State to take reasonable legislative and other measures within its available resources to achieve progressive realization of this right.

It is against this background that the municipality rounded up the commemorations with the registration of title deeds program in Ridge View in Siyathemba, on Sunday, 25th September 2022.

Dipaleseng Local Municipality encouraged community members to enjoy the braai day responsibly, within the confines of the law while protecting themselves and those around them.



GSDM IDP CONSULTATION

The Gert Sibande District Municipality held its first consultation for the 2022/23 IDP Review in Dipaleseng Local Municipality on Wednesday, 07th August 2022.

The District conducts rounds of consultations through the district local municipalities. \\\

The purpose of the stakeholder engagement is to commence analysis of the planning phase in terms of the Integrated Development Plan.

Also of note is to have critical look at information gathered and assess status of these challenges taking into consideration challenges experienced and ultimately set priorities in terms service delivery needs based on available budgets limits.

Some of the projects that were implemented by the District Municipality in Dipaleseng include;

- Water quality testing which is ongoing
- Rehabilitation of Roads
- Operation and Maintenance of Balfour WWTW
- Re-gravelling and Blading
- Regional Bulk Infrastructure Grant projects

Community as represented by the stakeholders present were able to actively participate in the deliberations in an effort to give clear perspective into community needs particularly in changing landscapes such as community growth and so forth.



Issues of illegal dumping site within the locality, refuse removal, finalization of Sizanani land issue and the speedy implementation of project that seeks to address water issues within the area as well as desludging of VIP toilets in rural areas.



INFRASTRUCTURE SERVICES - PROJECTS

The Municipality is implementing various capital projects on sanitation, electricity, water roads and storm water to address backlogs on services delivery issues.

The projects are funded and implemented by various departments including CoGTA, Department of Energy, SANRAL, Department of Water & Sanitation, Department of Higher Education, Department of Human Settlement and Sasol.

Council approved establishment of Project Management Unit (PMU) which is mandated for the Planning, Financial Management, Contract and Project Management; for the implementation, monitoring, evaluation and reporting sequence of actions with Municipal Infrastructure Grant (MIG), Municipal Capital Projects, and other sectors projects also ensuring functions and activities are aligned towards Integrated Development Plan (IDP), Service Delivery Budget Implementation Plan (SDBIP) and also aiming accomplishment of key service delivery objectives.

The department of Co-operative Governance and Traditional affairs (CoGTA) did approve the 5% of PMU operational budget of R 1 047 150.00 and the total approved budget for the implementation of MIG registered projects to the total value of R 20 943 000.00 for the 2022/23 FY. However, due to good performance on both MIG and INEP the municipality was re-allocated an additional budget of R 7 753 000.00 and R 4 500 000.00 respectively in the 2021/22 financial year.

However, the Municipality could not spend the entire R 7 753 000.00 on MIG but managed to spend R 4 500 000.00 on INEP. The municipality will apply for a roll-over of R 3 432 434.00 on the MIG programme.
