The first of the three day session, from Monday, 15th -17th January 2024, facilitated by the Mpumalanga Office of the Premier also involved the provision for an interactive session on the presented information from all the stakeholders which is to be utilized in making informed decisions for planning purposes moving onto the next two days.

BALFOUR REGISTERING AUTHORITY, CENTRE RECEIVES FAVOURABLE AUDIT OUTCOME

The Mpumalanga Provincial Department of Community Safety, Security & Liaison conducted an audit on the 10th January 2024 at the Balfour Registering Authority and found that files that were audited has not discrepancies.

The scope of the audit covered; Reconciliation of Face Value Control Sheets RE41, Cash Up for the month of May 2023, Application

and Issue of Professional Driving Permits for the month of May 2023, Application and Issue of Learners License for October 2023, Certification of Roadworthiness for May and October 2023, Authorization of Duplicate De/Registration of motor vehicles and Deregistration of motor vehicles for the month of May and October 2023.



The department regularly conducts these audit to verify required compliance to prescripts and set out regulations in terms of National Traffic Act of 1993/96.

The institution expresses profound gratitude to the Traffic

and Licensing Unit for their exceptional work and dedication which headed this successful audit outcome which is an accurate testament to their individual efforts and collective professionalism.

The department further urged the institution to continue with strict adherence to applicable prescripts and regulations governing the sector.



JOYOUS DAY FOR RIDGEVIEW RESIDENTS

On Monday, 18th March 2024, the Member of Executive Committee] of Human Settlements in Mpumalanga, Mr. SK Mashilo (MPL) descended to Ridgeview in Siyathemba in Dipaleseng Local Municipality to hand-over over a hundred title deeds to local home owners.

Child headed families, the elderly and people with disabilities will continue to be prioritized in the 720 left over sites in the area, wherein the Provincial Department will construct houses for them.

The rest of the available sites in the area will be allocated for private sale



and development in line with the mixed and integrated development plans for the area through the municipality.

The MEC committed to construct a community hall for the utilization of the com-





munity of Ridgeview in the coming future.

Though the event was not a community consultation, the Honourable MEC then allowed for engagements with the gathered community giving them an opportunity to voice concerns.



Accompanied by the Executive Mayors from Gert Sibande District Municipality and Dipaleseng Local Municipality, Cllr. Walter Mngomezulu and Cllr. Khethiwe Moeketsi respectively, the MEC officially opened a state of the art Early Childhood Development Centre also within the vicinity of Ridgeview.

A 70 year old Sarah Ndlovu who previously resided in Zone 2 in Siyathemba is one of three elderlies that were visited in their homes and



hand delivered these significant documents.

She was so delighted and couldn't contain her happiness as she explained how she even struggles to even walk.





1st Council Meeting for 2024

As legally required, Dipaleseng Local Municipality held its Ordinary Council Meeting on Wednesday, 31st January 2024 which was accordingly open for community members to attend and observe proceedings from the gallery.

Mr. Vusi Gcaba presented the 2022/23 Auditor General's Management Report for



Dipaleseng Local Municipality which revealed that the institution received a Qualified audit opinion, indicating that the institution did not regress but maintained its status. A

strong emphasis was placed on the entire culture and ecosystem of accountability to all stakeholders ranging from the Administration, Executive Authority, Council and its Oversight Committee all the way to Provincial Leadership and Parliament.



The Audit & Performance Committee report for the second quarter of the current financial year was presented to

Council by Mr. S Mofokeng who is the Chairperson of the Risk Management Committee on behalf of Chairperson, Mrs. Jane Masite who was not in attendance.

The Audit & Performance Committee concurred with the Auditor General on the Qualification outcome and all recommendations as presented. The report also came with key commitments from the Audit and Performance Committee and the Auditor General.

The second quarter performance for the institution indicated overall or average performance of 50% with regards to set targets in terms of the service delivery budget and implementation plan for the quarter which regrettably is a measurable decline compared with the same quarter year on year. Attributing factors to this declines have their genesis to the high vacancy levels at both senior managerial position and other key elementary positions within the organizational structure including the fiscal health of the municipality.



Opportunely, some reports which were tabled, such as the Integrated Waste Management Plan and Audit Action Plan reports, directly speak to remedial action/s in re-

sponse to Auditor General Report and concerns, importing the institution's trajectory towards a more positive outcome in the future.

Of particular worth to note were the revised 2023/24 MIG and new 2024/25 MIG



funded capital projects. This is necessitated by the fact that as at the end of December 2023, the municipality had received R7 13 570 000 and only managed to spend R 5 974 581, 00 which translated to a 29% expenditure on the overall allocation of R20 253 000, 00 which was below the targeted 40% and further should have reached 50% and above by the end of December

2023, which requires immediate intervention in order to avert funds from being forfeited due to poor expenditure.

In order to avert the above undesirable situation of continuous underperformance on the MIG funding, the resolutions at the Strategic Planning Session which was held from 15th to 17th January 2024 advised to revise its projects with a focus on those projects that are much more ready for implementation and are considered to be “low hanging fruits” and easily achievable and these include the acquisition of two new solid waste trucks and the designing of Charles Street.

Council members spent a relative amount of time and focus conferring on service delivery reports and matters as the institution undergoes slight pressures on certain service delivery areas within the jurisdiction.

After much consideration of the Mid-Term Budget and Performance Assessment, the municipality's Mid-year Budget Adjustment will be tabled before the end of February



2024, wherein all necessary budgetary adjustments will be duly reformed and approved as required by law. This will also allow the institution cause adjustments to its service delivery targets in accordance with the service delivery and budget implementation plans that are directly interlinked to individual performance of each senior manager.

Dipaleseng Council deliberated on all these matters as well as standing reports that ordinary council normally considers on a quarterly basis which also invited constructive debates amongst councilors. The current service delivery challenges especially in the delivery of reliable and potable water supply to all customers, call centre complaints, erratic electricity supply in some areas of the municipality and the state of municipal vehicles and fleet were also deliberated. The

need to encourage member of the public to enroll on the indigent register of the municipality was once again brought to attention and further encouragement to all consumers to pay for municipal services to sustain a fiscally viable institution that is able to render sustainable services. Lastly, the need to review Council Rules and Standing Orders was also proposed under the Speaker's reports.

Active participation of council members, management as well as other stakeholders continues to be appreciated as all the collective efforts assists in rowing this boat forward.



DRAFT BUDGET & IDP ADOPTED

The Council of Dipaleseng Local Municipality approved and adopted the 2023/24 IDP / Budget / Risk and PMS Process Plan on 25th July 2023, as per Council resolution C209 /07/23 as demanded by Section 29 of the Local Government: Municipal Systems Act of 2000 (No. 32 of 2000).

In terms of Section 29 of the MSA, the aforementioned process plan must inter alia indicate various planned activities and strategies which the municipality will embark on in the compilation and review of its IDP with an intention to enhance integration and alignment be-

tween the IDP, Budget, Risk and Performance Management System.



In implementing the process plan, there are five distinct phases which are systematically followed and guide the annual review and the important activities, deliverables to be considered during the different phases.

In the implementation of the approved and adopted process plan as mentioned above, phase 1, phase 2, phase 3, phase 4 has been successfully concluded, we are currently on Phase 5 which is in two folds the approval of the draft IDP in March 2024 and subsequently the approval of final IDP in May 2024.

Extracting from this, at a Special Council Meetings held on Thursday, 28th March 2024 at the local Council Chambers, the administration under the leadership of Municipal Manager, Mr. Lwazi Cindi tabled before Council a 3-year Medium Term Revenue and Expenditure Framework (Draft Budget) in terms of section 16 (2) of the Municipal Finance Management Act no.56 of 2003 as well as the draft Integrated Development Plan for 2024-2025 financial year.

Council thus approved the revenue budget of R 348.5 million for the 2024/2025 financial year, an operating expenditure budget of R 344.9 million with a operat-

ing budget surplus of R 3.5 million .

Similarly, Council approved the following revenue increases for the main five revenue sources with effect from 1 July 2024 as follows;

- increase in property rates by 4.9%,
- increase in the sewerage tariffs of 4.9%,
- increase in the refuse tariffs of 4.9%,
- increase in the water tariffs of 4.9%, and
- increase in the electricity tariffs of 12.7% pending NERSA approval.

Budget related policies such as the Cash collection and banking, Borrowing Policy, Cash collection and banking, Credit control & debt collection policy, Credit Control Policy, Asset Management Policy, Budget Policy, Provision for bad debts along with others were

According to this draft budget, all Registered Indigents will be provided a subsidy of R220.00 per month on their accounts.

The Draft integrated development plan for 2024-2025 financial year as approved by Council will be made public to allow for comments, inputs and submissions, moreover a defined schedule has been developed for utilization for consulting with communities and stakeholders for inputs before final approval
